SAB Finance a.s., with its registered office at Senovážné náměstí 1375/19, company ID: 24717444, listed at the Municipal Court in Prague, Section B, File 16383 (hereinafter “**SABF**”) and the **data subject** (an individual wishing to enter into a contractual relation or another legal relation with SABF, an entitled person, statutory body and a member of the statutory body of a legal person) agree that SABF registers and processes his/her personal data to the extent of the first name and surname, birth certificate number, profession (for entrepreneurs also the business name, company ID, registered office and subject of business), date of birth, address, telephone number, e-mail address, IP address, mailing address, sex, age, type and nature of the services used, including the manner and scope of their use, sociodemographic data, information on product and service use, information from product and service requests, information from telephone call records or other interactions between you and us, account balances, transaction data, geolocation data, information from the web browser you use, and data we obtain directly from you, from public sources (including social media and internet that you make available), information from surveys and user testing or from cooperating third parties, i.e. within the scope in which they were provided to SABF by the data subject in connection with a request to establish a business relation or in connection with any other contractual relation in the SABF database, in accordance with the Regulation (EC) No. 2016/679 of the European Parliament and the Council of April 27, 2016, on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter “general regulation on the protection of personal data”).

The personal data are processed automatically (electronically) and manually for marketing purposes. The purpose of the personal data processing is offering products and services provided by SABF and cooperating third parties also via electronic channels, marketing processing, analyses and profile forming which aim at customizing our offer to your needs and improving the quality of the rendered services. The data subject is entitled to refuse the personal data processing for marketing purposes, and such refusal will not affect the legal relation concluded. In case the data subject did not express his/her consent to the personal data processing by SABF prior to signing this document, it applies that he/she grants his/her consent by signing hereof.

In accordance with the general regulation on the protection of personal data, the data subject is entitled to request in writing the specification of personal data processed, purpose and nature of personal data processing, personal data recipients, to raise an objection to the processing of personal data and transfer the personal data to another controller. The data subject is also entitled to ask SABF for the personal data rectification in case he/she finds out that the processed personal data do not correspond to reality, their supplementing and to request restriction of processing and the personal data removal.
